Dear Ms. Smith

I was treasurer for Dr. Marc Flitter in his campaign for congressional representative for the Pennsylvania 21<sup>st</sup> district. As part of our duties we filed with your office FEC Form 3 Report of Receipts and Disbursements. In regard to this statement a complaint was filed stating that we might have violated the Federal Election Campaign Act of 1971.

Dr. Flitter had used a portion of the Erie, Pennsylvania Democratic headquarters for his campaign office but this was not reported on our original financial report. This had a fair market value of rent as an inkind contribution. As the rent exceeded the \$ 1,000 contribution limit allowed we prepared three corrected FEC reports, showing the rent as \$ 1,000 contribution and the portion in excess of \$ 1,000 as a debt. We forwarded these corrected FEC reports to your office (copies attached).

Would you review these corrected reports and advise us as to whether or not we are in compliance with reporting requirements.
