**Chronic Late Filing of Reports**

The Composition Roofers Local Union #30 Political Action & Education Fund ("the Committee") has failed to file four (4) Reports of Receipts and Disbursements in a timely manner for the 1997-1998 election cycle (see Chart on Page 2). The reports were filed between twenty-four (24) and thirty-nine (39) calendar days late.

On May 22, 1998, a Chronic Late Filer Notice was sent to the Committee for failing to file the 1997 Year End and 1998 April Quarterly Reports in a timely manner (Attachment 9). The Notice advised the Committee that any additional late filing of reports may result in legal enforcement action.

Subsequent to the mailing of the Chronic Late Filer Notice, the Committee failed to file the 1998 July Quarterly and 1998 30 Day Post-General Reports in a timely manner.




