I. PRELIMINARY STATEMENT

Jack A. Abramoff, through undersigned counsel, submits this response to the February 14, 2006 Complaint filed by Edward Wigglesworth of TheRestofUs.org ("Complainant"), which alleges that Mr. Abramoff contributed \$34,750 to federal candidates in 2002, in violation of the \$25,000 aggregate yearly limit under 2 U.S.C. §441a(a)(3).

II. THE COMPLAINT

The Complaint, relying on information from the Federal Election Commission's (Commission's) website, alleges a single violation: that Mr. Abramoff "contribut[ed] \$34,750 to federal candidates and committees in 2002, in violation of the \$25,000 aggregate yearly limit on contributions to federal candidates and committees set forth in 2 U.S.C. Section 441a(a)(3) prior to its amendment by the 2002 Bipartisan Campaign Reform Act." Complaint, p. 1.

The Complaint then lists 22 contributions that Mr. Abramoff allegedly made during 2002, the total of which is \$34,750. Complaint, pp. 2-3. Item (i) of this list states: "On June 10 [2002]: \$5,000 to Battle Born Classic Committee, FEC ID#C00370296; [File Image]." Item (k) states: "On June 25 [2002]: \$5,000 to Senate Victory Fund PAC, FEC ID# C00202861; [File Image]." Indeed, all 22 contributions on the list, (including items (i) and (k)), match the records posted on the Commission's website, along with the linked "file image" for each record. Id.

III. FACTS

Mr. Abramoff, in fact, contributed only \$24,750 to federal candidates in 2002. The confusion stems from a simple and easily demonstrated clerical error. Two political action committees (PACs), in their filings with the Commission, mistakenly attributed \$10,000 worth of contributions to Mr. Abramoff that were actually contributed by his wife, Pamela Abramoff.

Consequently, the Commission's website, in turn, includes \$10,000 worth of contributions to Mr. Abramoff that were not his contributions. When the contributions are properly attributed, it becomes clear that Mr. Abramoff contributed \$24,750 (not \$34, 750) to federal candidates in 2002 and Mrs. Abramoff contributed \$20,000 (not \$10,000) to federal candidates in 2002, neither exceeding the \$25,000 limit.

The clerical error is readily demonstrated by cross-referencing the information listed on the Commission's website against Pamela Abramoff's canceled checks. According to the Commission's website, Pamela Abramoff made seven contributions to federal candidates in 2002, for a total of \$10,000. See Exhibits A and B.¹ However, this is in error because the Commission website does not include two \$5,000 contributions that Mrs. Abramoff made in that year. Specifically, the website does not include one \$5,000 contribution Mrs. Abramoff made to the "Battle Born Classic Committee" on May 31, 2002 and one \$5,000 contribution she made to the "Senate Victory Fund" on May 17, 2002. Id. Those contributions should have been listed under her name because, as the canceled checks for the contributions show, it was Pamela Abramoff, not Jack Abramoff, who made them. See Exhibits C and D. The checks, drawn from the couple's joint checking account, were signed only by Pamela. Id.

¹ The Commission's web site generates different search results for "Pamela Abramoff" than for "Pam Abramoff." The "Pamela" search yields only \$38,250 worth of total, overall contributions, which is apparently a subset of the results of the "Pam" search, which total \$57,250. In any event, both searches display the same seven contributions for Mrs. Abramoff in 2002, which total \$10,000.

This attribution error apparently resulted when the PACs reported the contributions to the Commission as Mr. Abramoff's, not Mrs. Abramoff's, in their "Schedule A Itemized Receipts" filings. See Exhibits E and F. Although this was a mistake on the part of the PACs, they likely made this mistake because the contributions were derived from a joint checking account where the name "Jack A. Abramoff" appears higher and more prominently than "Pamela C. Abramoff." However, the checks themselves show that the PACs should have listed the contributions as Mrs. Abramoff's because it was she who signed them. See Exhibits C and D.

Because of the PACs' reports, the Commission's website erroneously attributes these two contributions to Jack Abramoff, as is seen in Exhibit G, at "9 of 12" and "11 of 12." (Jack Abramoff attributed with contributing \$5,000 to the "Battle Born Classic Committee" recorded on June 10, 2002 and another \$5,000 to the "Senate Victory Fund" recorded on June 25, 2002.)

IV. ANALYSIS

Federal election laws in 2002 limited the amount that individuals could contribute per year to federal candidates, providing that "No person shall make contributions aggregating more than \$25,000 in any calendar year." See Current 2 U.S.C. §441a(a)(3), Notes: 2002 Amendments. In accordance with the plain meaning of "person," the Commission's "Citizens' Guide" allows that a husband and wife "each have separate contribution limits."² The "Citizens' Guide" also permits a married couple to contribute individually out of a single joint checking

² The "Citizens' Guide" on the Commission's current website states: "A husband and wife each have separate contribution limits, even if only one spouse has an income." See <http://www.fec.gov/pages/brochures/citizens.shtml>.

account, so long as the proper individual signs the check to indicate which individual the contribution is coming from.³ Likewise, the Commission's regulations provide that, at least in the context of Matchable Contributions, "[i]n cases of a check drawn on a joint checking account, the contributor is considered to be the owner whose signature appears on the check." 11 C.F.R. §9034.2(c)(1).

Therefore, the two contributions of \$5,000 to the "Senate Victory Fund" and the "Battle Born Classic Committee" should have been credited to Pamela Abramoff's individual contribution limit under 2 U.S.C. §441a(a)(3), regardless of whether the checks came from a joint account. Pamela signed the checks; Jack did not. Pursuant to 11 C.F.R. §9034.2(c)(1), such a contribution must be attributed to the person whose signature appears on the checks. Once this error is corrected and all contributions are attributed to the proper individual, both Jack Abramoff and Pamela Abramoff fall comfortably within the prescribed individual contribution limit of \$25,000. Jack Abramoff contributed a total of \$24,750 to federal candidates in 2002, and Pamela Abramoff contributed a total of \$20,000.

V. CONCLUSION

The two canceled checks-- both signed only by Pamela Abramoff-- establish that the two contributions that allegedly put Jack Abramoff over the \$25,000 limit for 2002 were, in fact, not

his. They were Pamela's. Both Jack and Pamela Abramoff each contributed less than the \$25,000 limit. The Commission should therefore find no reason to believe that a violation of federal election law has occurred, and dismiss the Complaint.
