Dear General Counsel:

I am writing in response to your letter of November 15, 2006. I wrote to you on November 7 to report what I believe to be a violation of campaign ethics. According to your letter of November 15, the statement of the notary that I included with the November 7 letter was inadequate. I will restate my complaint in the present letter and enclose a statement by a notary to the effect that I swore to the truth of the following complaint.

I was the Democratic candidate for the House of Representatives in California's Third Congressional District. I was endorsed by the California State Democratic Party and by all the local Democratic clubs and committees in the Third District that made endorsements in my race against the Republican incumbent, Dan Lungren.

A few days prior to the November 7 election, many voters in our district received a slate mailer which appeared to come from the Democratic Party. The slate mailer, which I enclosed with the November 7 letter, included phrases such as, "Attention Democrats" and "Vote Democratic." The mailer listed Democrats as the choices for all major state offices, but listed my Republican opponent, Dan Lungren, as the choice for U S Congress. The mailer also listed a Republican, Roger Niello, for State Assembly, and recommended positions on state propositions that were not consistent with the state Democratic platform.

According to the footer on the slate mailer, it was sent by "Democratic Voters Choice" in Burbank, California. We have determined that "Democratic Voters Choice" is not an organization that has been officially sanctioned by the State Democratic Party.

I believe that the slate mailer represents a deliberate attempt to trick Democratic voters into voting for the Republican candidate, Dan Lungren. I further believe that this mailer unfairly affected my chances of winning this election. I would appreciate it if the FEC would investigate this manner.

The mailer listed Democrats as the choices for all major state offices, but listed my Republican opponent, Dan Lungren, as the choice for U.S. Congress. The mailer also listed a Republican, Roger Niello, for State Assembly, and recommended positions on state propositions that were not consistent with the state Democratic platform.

According to the footer on the slate mailer, it was sent by "Democratic Voters Choice" in Burbank, California. We have determined that "Democratic Voters Choice" is not an organization that has been officially sanctioned by the State Democratic Party, and that the name of the treasurer, Kinde Durkee, appears on the California Fair Political Practices Commission website in association with campaign ethics violations. I do not know at this time what if any relationship exists between "Democratic Voters Choice," Kinde Durkee, and my Republican opponent, Dan Lungren.

I believe that the slate mailer represents a deliberate attempt to trick Democratic voters into voting for the Republican candidate, Dan Lungren. I further believe that this mailer unfairly affects my chances of winning this election. I would appreciate it if the FEC would investigate this manner.


