On June 23, 2009, I was unexpectedly terminated from my architectural firm, Tate Snyder Kimsey in Las Vegas, Nevada. I believe that my shareholder position was terminated without just cause and in violation of the shareholder's agreement. The reason for my firing was documented as "lack of work". The real reason is that my partner had a deep running animosity towards me as I am gradually becoming the face of the firm as far as our design practice is concerned. We also had numerous disagreements as I exercised professional skepticism about my partner's activities.

One of the disagreements between me and Windom Kimsey and ex-partner, William (Bill) Snyder, who is a governor-appointed member of the Nevada State Board of Architecture, was that they had organized an enterprise to make illegal campaign contributions to Senator Harry Reid's senatorial campaign this past February 2009. I resisted the coercive effort to contribute by telling them that I could not afford to make the suggested \$1,000 contribution. I told Windom Kimsey that I did not understand if this was a legal activity and that we should also not force our political will on the other workers in the office. One of the partners then made it very clear to me that "anyone who did not make a contribution will not have any work for the upcoming year." There are witnesses to his threatening statement who have told me that they are willing to testify to this effect. Out of fear of losing my job I told them that I will go ahead and make a contribution - but I did not have \$1,000 in my checking account. They told me that it was not a problem and immediately forwarded me the money through the disguise of my periodic expense reimbursement. I found out that they were also reimbursing others in the office for the same purpose. I believe that the other employees who possibly arranged with Windom Kimsey and Bill Snyder to receive reimbursement money for their contributions are:

They also possibly used the same coercive threat of "anyone who did not make a contribution will not have any work for the upcoming year" with the following consultants:

As I investigated further I also found that there was a contribution made by Maizie Pusich. Maizie is not an employee of the firm, nor is she an architect. Maizie is the Deputy Chief Public Defender for Washoe County. There was a contribution made by Dwayne Miller. Dwayne is not an employee of the firm, nor is he an architect. Dwayne is a principal at JBA consulting engineers. I found that these contributions were reported to the Federal Election Commission possibly to give the appearance that both were employees of the firm and architects. I believe these are possibly fraudulent filings to demonstrate that Tate Snyder Kimsey was able to meet the minimum \$25K threshold requested by Harry Reid's office for the campaign contributions. There was a fund raiser held on February 17, 2009 for the Friends of Harry Reid campaign fund. As the event date was approaching, Windom Kimsey and Bill Snyder began to panic as there were very few, if any, contributions being made. That's when the desperation, coercive threats, and money funneling scheme started to occur.

These illegal and desperate actions were taken by Bill Snyder and Windom Kimsey to influence Senator Harry Reid in order to gain support for an upcoming federal contract through the GSA. The contract is for architectural and engineering services for the renovation of the Otay-Mesa port of entry at the U.S. and Mexican border in California. The contract is worth millions of dollars. The consultants mentioned above are all part of the design team for the Otay-Mesa project. It is my understanding that Tate Snyder Kimsey has successfully executed that contract - following the campaign contributions. It is obvious that Senator Reid's influence over the GSA to let the contract to Tate Snyder Kimsey was effective.

I have attached annotated supporting documents reflecting the crimes noted above.


