Dear Dr. Templeton.

Thank you for your recent call and response to our letter of April 11, 2001. I appreciate your response and assistance in resolving the issues regarding the federal election campaign contributions you made during the 1999 and 2000 election cycle

I have enclosed a print-out from the Commission's Public Disclosure Office of the contributions you made during the years 1999 and 2000. According to those records you exceeded the limits specified in the statute, i.e., 2 U.S.C. § 441a(a)(3), for aggregate contributions to candidates for federal office. As we discussed, I suggest you review the enclosed listing and then contact this office so we may resolve this matter as quickly as possible.

Let me reiterate the comment made during our discussion on April 17<sup>th</sup>. We appreciate you bringing to our attention the contributions you made to federal election campaigns during the two previous years. Our effort now is to help ensure that your future contributions to federal elections are in compliance with federal campaign law. To assist in that effort, I have enclosed a copy of the federal statute governing federal election campaigns and two brochures that may be of further assistance.

I look forward to hearing from you and jointly bringing this matter to speedy resolution.
